Key Outcomes of OWIT Fall 2016 Board Meeting

1. Strategic Plan 2025 Adopted

At the Fall 2015 Board meeting (hosted by OWIT-South Florida), the Board launched Strategy Quest- a year-long conversation to determine the OWIT we want to see in 2025. This process culminated at the Fall 2016 Board meeting in Geneva. With expert facilitation by OWIT's VP-Strategy, Violette Ruppanner of OWIT-Geneva, the Board developed and adopted a <u>Strategic Plan through 2025</u>. The first six-month implementation plan was also developed.
